## **BACKGROUND**

### The Northern Ireland Judicial Appointments Commission

The Northern Ireland Judicial Appointments Commission (the Commission) was established on 15 June 2005 under the Justice (Northern Ireland) Acts 2002 and 2004. This legislation implements the recommendations of the Northern Ireland Criminal Justice Review.

The Commission is an independent Non-Departmental Public Body comprising 13 members appointed by the Lord Chancellor and drawn from the judiciary, the legal profession and members of the public who are not qualified lawyers. The Chairman is the Lord Chief Justice of Northern Ireland, Sir Brian Kerr.

The Commission is supported by a secretariat of 16 staff, headed up by Alan Hunter (Appendix D)

### The Commission's roles and responsibilities

The Commission has five key roles:

- 1. To conduct the appointments process and make recommendations to the Lord Chancellor in respect of all listed judicial appointments up to and including High Court Judge.
- 2. To recommend candidates solely on the basis of merit.
- 3. To engage in a programme of action to secure, so far as it is reasonably practicable to do so, that appointments to listed judicial offices are such that those holding such offices are reflective of the community in Northern Ireland.
- 4. To engage in a programme of action to secure, so far as it is reasonably practicable to do so, that a range of persons reflective of the community in Northern Ireland is available for consideration by the Commission whenever it is required to select a person to be appointed, or recommended for appointment, to a listed judicial office.
- 5. To publish an annual report setting out the activities and accounts for the past year.

### Key Focus

The Commission was established on 15 June 2005. Our key objective, for this our second year, shall be to meet the very demanding programme of appointments and re-appointments (schedules attached at Appendix B + C) and the associated programme of action for each. During this time our objective is also to carry out an extensive review of our appointment policies and procedures and to consult upon our findings. We also look forward this year to consulting upon and publishing our first Corporate Plan, which sets out our objectives and goals for the next 3 years and the principles which will inform our work over this period. Our first Annual Report, setting out our achievements and performance during our first year to March 2006, shall also be published. Strong corporate governance and an ability to demonstrate effectiveness and value for money in our achievements shall be a focus that impacts on all the work we do.

## **OBJECTIVES**

This business plan sets out below the Commission's objectives, under the three perspectives of business results, interested parties and internal issues, and outlines the timetable they shall be delivered within.

### **Business Results**

- 1. To make recommendations to the Lord Chancellor for appointments to listed judicial offices in accordance with Appendix B.
- 2. To make recommendations to the Lord Chancellor for reappointments to listed judicial offices in accordance with Appendix C.
- 3. Develop and agree a programme of action to facilitate each of the appointments and re-appointments, and to deliver the programme over the period.
- 4. By 31 March 2007 to have prepared material for inclusion in the Commission's 2006/2007 Annual Report.
- 5. To complete the equity monitoring of the existing judiciary and carry out equity monitoring of applicants for schemes.
- 6. To develop and implement a research programme relating to the judiciary, specifically relating to gender issues.

#### **Interested Parties**

- 7. By 31 October 2006 the Commission shall have consulted upon its Corporate Plan for publication by 31 January 2007.
- 8. To have available for publication its 2005/06 Annual Report within 2 months of audit by National Audit Office.
- 9. To have in place a publication scheme within 1 month of approval by the Information Commissioner's office.
- 10. By December 2006 to have in place effective SLAs with the sponsor departments.

### <u>Internal</u>

- 11. By 31 March 2007 to secure from the NICtS the required level of resources to deliver the Commissions 2007/08 objectives.
- 12. To maintain internal financial and stewardship controls within the Commission, which meet central government guidelines.
- 13. To appoint a Chief Executive to the Commission within the agreed timetable.
- 14. To demonstrate strong corporate governance at all times.
- 15. To benchmark the Commission's corporate services as per the Internal Audit Service Audit Plan to ensure value for money.
- 16. To ensure that staff are equipped to support the Commission by reviewing staffing resources and turnover.
- 17. To recruit two Grade 7 posts.


